#### **Editorial**

CROP is first and foremost a network of researchers. But it is important that CROP also moves on arenas where research based knowledge on poverty issues are sought. During the last month CROP has had the good fortune to provide inputs into two such arenas.

The papers and the discussions from the CROP/IIED workshop on <u>Urban Poverty</u> in Bergen will be used in the forthcoming background report for the UN conference on Human Settlements which is to be held in Istanbul in 1996. Dr. David Satterthwaite, who co-organized the workshop with CROP, has been appointed by the UN to write the report. A selection of papers from the workshop will also appear as an independent volume in <u>Environment and</u> Development in April 1995.

In 1992 the UN General Assembly put the topic of "Human Rights and Extreme Poverty" into a resolution, expressing its "deep concern about extreme poverty spreading all over the world, hindering the most disadvantaged and vulnerable part of the populations exercising their human rights and fundamental freedom." As a follow-up, the UN Centre for Human Rights was requested to organize a seminar on Extreme Poverty and Human Rights. The seminar was held October 12th-14th in New York. CROP was represented by its Chair who gave a key note paper. The proceedings and recommendations from the seminar will be fed back to the UN.

The next opportunity to provide an input into the UN arena is the UNESCO/CROP Roundtable on Poverty and Participation in Civil Society during the UN Summit on Social Development. Speakers will be: Robert Chambers, U. of Sussex, Elisabeth Jelin, U. de Buenos Aires, Sadig Rasheed, ECA, Addis Ababa, and Amartya Sen, Harvard. The Round Table will be held in the Eigtvedt Pakhus, at the Danish Ministry of Foreign Affairs, Tuesday March 7 1995, from 4 p.m. to 7 p.m. If any of you are in Copenhagen then, you are invited to come and share your expertise with us and the audience of politicians, bureaucrats, NGO's and other interested parties.
